

## SUDDATH: COVID-19 IMPACT ASSESSMENT

Updated: April 6, 2020

The table below lists Suddath's physical locations and how our services in each region have been impacted by Stay-at-Home and Shelter-in-Place orders and local curfews.

Essentially every operating location in the US is under some form of restriction, and many states/counties are issuing their mandates using the same reference to the US CISA Critical Infrastructure criteria, which allow for flexibility for Suddath as a critical service provider for commercial and logistics operations. Household goods operations can be more limited in certain markets by driver/crew availability.
